- ADVANCED CONCRETE RAISING, INC. assumes normal construction and concrete thickness for purpose of this proposal and that such construction conforms with standard municipal codes. If the existing construction and/or concrete are not of normal construction or do not meet the standard municipal building codes, or if previous concrete underpinning/piers are encountered, an additional charge may be required to prepare the effected area for proper installation. The property owner(s) or their agent(s) agree to pay such an additional charge pursuant to this contract if the above described event(s) are encountered.
- ADVANCED CONCRETE RAISING, INC. will not be responsible for tile, carpet, paneling, appliances, air conditioners, outside plantings, etc. that need to be removed and replaced but will exercise care. The property owner(s) or their agent(s) bear the burden to investigate and disclose the existence of any underground facilities as the same may be amended, located in or near the areas which the property owner(s) or their agent(s) have requested ADVANCED CONCRETE RAISING, INC. to excavate and/or repair. ADVANCED CONCRETE RAISING, INC. shall not be liable for any damage caused to such underground facilities if such facilities are not disclosed by the property owner(s) or their agent(s). The property owner(s) or their agent(s) are responsible for ensuring compliance with any and all laws, statues and ordinances related to engaging in sub-surface activities on the property owner(s)' property including, but not limited to, notice and filing requirements. The property owner(s) or their agent(s) shall indemnify and hold ADVANCED CONCRETE RAISING, INC. harmless for any consequential sub-surface damage caused by ADVANCED CONCRETE RAISING, INC. property owner(s) or their agent(s)' failure to meet their burden hereunder.

A request for mediation or demand for arbitration shall be filed in writing with the other party with a copy to The Mediation Center, CIMAAC, 418 South Clay, Kirkwood, MO 63122, and shall be made within a reasonable time after the dispute has arisen. The award rendered by the arbitration shall be final.

This warranty is transferable in its entirety to subsequent property owners, provided that an assignment is properly executed. If any Z" vertical (settlement) horizontal movement occurs in the area described in paragraph 1. Above, other than settlement or movement caused by earthquake, severe wind, flood, slope or hill movement, extreme change in water table (upheaval), other Act-of-God, or similar man-made conditions including, but not limited to, explosions, mine subsidence, improper drainage, or abandonment of building, then ADVANCED CONCRETE RAISING, INC. will, at NO COST OR EXPENSE TO THE PROPERTY OWNER(S), correct any defect in workmanship or materials that may have occurred in order to stabilize such area. If there is mudjacking done Advanced Concrete Raising Inc. is not responsible for damage to plumbing or electrical, cracks in floors or walls or any damage which has occurred or might occur as a result of the settling or mudjacking process.

NOTE: This proposal may be withdrawn by ADVANCED CONCRETE RAISING, INC. if not accepted within 30 days.
