Meeting was held to discuss the structure of the Subdivision. In the process of working on the Boat Pier Agreement many questions about the structure of the Subdivision have come up by attorneys. This structure includes Covenants, By Laws, Non for-Profit Status, and what kind of Tax Returns we have been filling.

Attorney Lauren from Burke, Costanza, and Carberry LLC. Who we previously were dealing with will no longer represent us or take on the task of the Boat Agreement.

Troy R. made a motion to hire Brian Hittinger from Krieg Devault Law Firm. Erin G. seconded. All Directors in Favor.

Meeting held to discuss findings from meeting held with Alice D. and Barb. V. with Attorney Brian Hittinger from Krieg Devault Law Firm, 8001 Broadway, Suite 400, Merrillville, IN 46410.

Current Structure of the Subdivision – We are a Non for-Profit Corporation and we do not secure
a non-profit 501c3 status – Good News! We have been filing the right taxes forms –1120 – HOA
Tax Returns. We can continue to file the same as in the past. Covenants –We are fine without.
Articles of Incorporation –The are good and will stand as Covenants. The By-Laws need
amended and recorded, same with Rules and Regulations. Need amended important due to
language.

Brian gave an estimate of \$3,000.00-\$5,000.00 to cleanup/fix documents, and a timeline of 2 to 3 months.

The Attorney did say that S.S.I.A. owns and controls the park.

2. Boat Pier – Discussed structure – No matter what the status or structure of the Association there no difference in liability protection. He did say that it would be beneficial to make a Subsidiary of the Corporation for the Boat Pier. This would be due to the Pier could be taxable.

Brian gave an estimate of \$5,000.00-\$7,000.00 to create the Subsidiary.

- 3. A discussion and creation of an email that will be sent out to interested boat pier members to discuss this, and money need to move forward. See attached email.
- 4. Barb V. made a motion to sign the Engagement Letter from the Attorney to work/amend the current By-Laws and Rules and Regulations. Seconded By Troy R. All in Favor
